恆指似做頭肩底 - 國內券商股要吼

恆生指數上週升 582 點,已經補回十月初(26172-25392)裂口,漸漸似形成頭局底型態,如能企穩 26500 重要支持位,有望更上一層樓;如無意外的話,十一月將會扭轉六連跌的情況,其實主要原因是港股之前嚴重超賣,市場趁低吸納,不過反彈目標以優質和市值大的股票為主,三四線股份依舊受壓,市場資金不足,不少證券行都出現收縮孖展額,加上聯交所打壓殼股,都令三四股雪上加霜。

近排國內券商走勢不錯,據報滬倫通經紀業務有望 12 月 8 日上線,對內地大型券商有利,更重要是中證協公布了資管計劃以支持私營企業,並解決與股票質押回購業務相關的風險及壓力為券商提供了更大的靈活性;中信證券(6030.HK)作為國內最大的證券商,係近日扶持民企政策上,擔任一個重要角色,有望第四季業績重拾增長。\$15 以下可買入,上望\$18, 跌穿\$14.3 止蝕。
